# 1. Program Overview プログラムの概要

The mission of the University of Osaka is to nurture outstanding individuals who possess a high sense of ethics and wish to become global citizens and leaders in a variety of fields worldwide under the objective of "Live Locally, Grow Globally".

For this reason, the Department of Mathematics, the Department of Physics, the Department of Chemistry, and the Department of Biological Sciences in the School of Science have established the International Undergraduate Program in Science (IUPS) for international students.

Students will be enrolled in the program for 4.5 years in total (half a year as a research student and 4 years as an undergraduate student), culminating in the award of a bachelor's degree.

This program is overseen by the International College and the School of Science of the University of Osaka.

The School of Science and the International College welcome:

- Applicants who are curious, have a strong interest in natural science, and are enthusiastic about broadening their knowledge base.
- Applicants who aim to contribute to the development of science and technology and thus to the whole of society.
- Applicants who have a desire to participate in the creation of new academic disciplines.
- Applicants who wish to develop their ability to describe and present their ideas logically, and improve their communication skills along with their research capabilities in both English and Japanese.
- > Applicants who are ethically grounded.

#### The outline of the program is:

- Entrance examinations are conducted in English by each department (or in English and Japanese in the case of the Department of Mathematics and the Department of Biological Sciences).
- For six months prior to regular enrollment, students attend intensive Japanese language education classes and some preliminary science classes at the Center for Japanese Language and Culture (CJLC). During this time, students will be enrolled as research students. The nature of the Japanese language education classes will depend on each student's individual Japanese language ability.

- > Students will then be enrolled as undergraduate students. In the first year, students will take classes mainly in English, and study liberal arts and science major subjects.
- Further advanced Japanese language education will be offered until the end of the second year of the undergraduate program.
- Students will focus on specific subjects in their respective majors from the second year, and the classes will transition from mainly being taught in English to mainly being taught in Japanese.
- > Students will be assigned to a specific laboratory to conduct research in their final year.

# 2. Duration of the Program プログラム期間

Preliminary and intensive Japanese language education (as a Research Student of the Center for Japanese Language and Culture):

From October 1, 2026 to March 31, 2027 (6 months)

Undergraduate School (as an Undergraduate Student of the School of Science):

From April 1, 2027 to March 31, 2031

#### 3. Student Intake 募集人員

The number of students admitted each year will be small to allow for intensive supervision. Students can be admitted to one of the following four departments:

- Department of Mathematics, School of Science
- Department of Physics, School of Science
- Department of Chemistry, School of Science
- Department of Biological Sciences, School of Science\*
  - \*Successful applicants will be assigned to the Biological Sciences Course of the Department of Biological Sciences.

# 4. Eligibility for Application 出願資格

In order to apply to this program, applicants must meet certain requirements set by the Japanese Ministry of Education, Culture, Sports, Science and Technology (MEXT). Accordingly, students meeting at least one of the following criteria by September 30, 2026 can apply.

(1) International applicants (students from outside of Japan) who have completed a standard 12-year school education curriculum of a country other than Japan. Included

- here are applicants who have completed a standard 12-year school education curriculum in a country outside Japan in less than 12 years as a result of being promoted up a grade ahead of their peers.
- (2) International applicants who are at least 18 years of age and who have passed an examination in a country other than Japan that certifies that they have scholastic ability equivalent to a person who has completed a standard 12-year school education curriculum in the said country.
- (3) International applicants who have completed a school curriculum in a country other than Japan that corresponds to that of a senior high school in Japan (including those who have passed an examination which certifies that they have scholastic ability equivalent to a person who has completed such a curriculum), and who have completed pre-university preparatory education required for admission to Japanese universities as designated by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (4) International applicants who have completed a curriculum in a school that is considered to be the equivalent of high school (upper secondary) level and have met the requirements stipulated by the Japanese Ministry of Education, Culture, Sports, Science and Technology. The applicants should have completed at least 11 years of education in a country outside Japan at institution(s) that meet standards laid down by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (5) Applicants who have completed a program of study in Japan at an educational institution offering a 12-year curriculum of a foreign country designated as equivalent to senior high school in that country by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (6) Applicants who have completed a program of study in Japan at an educational institution offering a curriculum of a foreign country consisting of less than 12 years and considered equivalent to senior high school in that country, and completed preuniversity preparatory education required for admission to Japanese universities as designated by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (7) Applicants who have obtained the International Baccalaureate qualification awarded by the International Baccalaureate Organization in Switzerland.
- (8) Applicants who have obtained the Abitur issued by the Federal Republic of Germany for college entrance.
- (9) Applicants who have obtained the Baccalaureate Diploma issued by the French Republic for college entrance.

- (10) Applicants who have obtained the General Certificate of Advanced Level or the International General Certificate of Advanced Level accredited as a qualification for admission to a university in the United Kingdom of Great Britain and Northern Ireland.
- (11) An applicant who has obtained the European Baccalaureate Diploma issued by the European Union for college entrance.
- (12) Applicants who have completed the standard 12-year school curriculum in one of the special schools for foreigners in Japan that are certified by the international evaluating organizations designated by the Ministry of Education, Culture, Sports, Science and Technology (WASC, ACSI, CIS, NEASC, Cognia and COBIS).

#### Notes:

- \* Applicants who have completed their studies at a non-accredited international school in Japan, or are unsure whether they are eligible to apply, should contact the office of the International College as early as possible before applying.
- \* Applicants are encouraged to apply only if they plan to pursue their studies continuously and without interruption from enrollment to graduation. In particular, applicants from countries with compulsory-military-service requirements should ensure they do not have to fulfill their military-service requirements while enrolled in the program.
- \* In case applicants do not arrive in Japan by the date designated by the university, their enrollment might be cancelled even if they would be able to start their studies by October 1, 2026.
- \* Even after enrollment, applicants can be expelled for poor attendance or unsatisfactory grades.

# 5. Application Procedure 出願手続

- (2) After completing the registration, applicants should pay the application fee by pressing the "Continue to pay" button. For more details, please refer to section 7 "Application Registration and Application Fee Payment".
- (3) After completing the payment of the application fee, applicants will receive an automated reply e-mail containing a URL for downloading the application form and a mailing address for the application documents.
- (4) Finally, applicants should fill out the application form and send it with the other required application documents to the mailing address provided in the automatic reply

e-mail after completing the payment of the application fee. The application documents must be sent by a registered mailing service such as EMS, FedEx, DHL, UPS, etc.

Important notes when preparing the application documents:

- \* Applicants who have not yet graduated from high school at the time of application may submit a certificate of expected graduation and predicted scores for the academic transcript. Finalized graduation certificates and academic transcripts must be sent once they become available.
- \* If subjects and score details on the academic transcript are written in codes or abbreviations, the appropriate description in English should be attached.
- \* All certificates and other documents need to be certified copies as issued by the school principal or the corresponding highest-level administrator.

# Application Documents-3

#### Letter(s) of Recommendation 推薦書

Applicants must have at least one letter of recommendation submitted from the principal and/or a senior science teacher of the last secondary school they attended. A science teacher who knows the applicant well is preferable. The letter(s) must include an evaluation of both their personality and academic ability. The letter (s) must be on official letterhead, signed by the principal/teacher, and sealed with the signature of the person who wrote it (unsealed letters will not be accepted).

### Application Documents-4

Results of Standardized Test(s) for University Admission 大学入学共通テストの結果

#### For the Department of Mathematics and the Department of Biological Sciences

(1) International Baccalaureate (IB)

Applicants who studied under the International Baccalaureate Educational System (IB) should submit a copy of their International Baccalaureate Diploma and their IB final examination performance evaluation certificate for

- a) HL Mathematics.
- b) For the Department of Mathematics, two results out of HL Physics, HL Chemistry and HL Biology. For the Department of Biological Sciences, only HL Physics and HL Chemistry are accepted.

The institution code of the University of Osaka for IB is 036164.

(2) General Certificate of Education Advanced Level (GCE A-Level)

Applicants who studied under the GCE Advanced Level System should submit:

- a) Either GCE Advanced Level Mathematics or Further Mathematics results,
- b) For the Department of Mathematics, two GCE Advanced Level results out of three from Physics, Chemistry and Biology. For the Department of Biological Sciences, only Physics and Chemistry are accepted.

For the Department of Mathematics, students are highly recommended to submit results for Further Mathematics instead of Mathematics. The Department of Biological Sciences accepts either Mathematics or Further Mathematics.

(3) Examination for Japanese University Admission for International Students (EJU)

Applicants not belonging to the above two categories should submit official scores of the Examination for Japanese University Admission for International Students (EJU). In this case, the required EJU Subjects, either in English or Japanese, are

- a) Mathematics Course 2,
- b) For the Department of Mathematics, two results out of Physics, Chemistry and Biology. For the Department of Biological Sciences, only Physics and Chemistry are accepted.

(Note that we accept EJU scores also from candidates that have studied in the IB or GCE systems, if they wish to send us EJU scores in addition to IB or GCE results.)

- (4) Please note the following:
- a) If the documents to be submitted are written in a language other than English, a verified translation into English needs also to be sent. Verification of a translation (consistency

between the translations and the originals) may be obtained at an embassy, at the high school of the applicant, or at other organizations.

b) For applicants submitting standardized test results that are not automatically delivered to the IUPS by the organization providing the standardized test and that require the applicant's authorization for results to be verified by third parties (such as the IUPS), applicants will be asked at a later time to complete the appropriate authorization document allowing this authorization. The IUPS will reject applications for which the requested authorization will not be provided by the applicant.

#### For the Department of Physics, and the Department of Chemistry

#### (1) International Baccalaureate (IB)

Applicants who studied under the International Baccalaureate Educational System (IB) should submit a copy of their International Baccalaureate Diploma and their IB final examination performance evaluation certificate. The institution code of the University of Osaka for IB is **036164**. Preferred subjects are:

- **For the Department of Physics**: HL Mathematics, HL Physics, and either HL Chemistry or HL Biology
- **For the Department of Chemistry:** HL Mathematics, HL Chemistry, and either HL Physics or HL Biology

#### (2) General Certificate of Education Advanced Level (GCE A-Level)

Applicants who studied under the GCE Advanced Level System should submit one of the following:

- a) Their results of three GCE Advanced Level subjects.
- b) Their results of a total of four subjects: two GCE Advanced Level and two GCE Advanced Subsidiary Level.

Preferred subjects for both a) and b) are Mathematics, Physics, Chemistry, and Biology.

Please note that the authorization procedure described at (4) below will be required for many providers of A-level examinations.

#### (3) Others

Applicants not belonging to the above two categories should submit, if possible, official scores of the Examination for Japanese University Admission for International Students (EJU). In this case, the required EJU Subjects, either in English or Japanese, are as follows.

- **For the Department of Physics**: Mathematics Course 2, Physics, and either Chemistry or Biology
- **For the Department of Chemistry:** Mathematics Course 2, Chemistry, and either Physics or Biology.

Note that we accept EJU scores also from candidates who have studied in the IB or GCE systems, if they wish to send us EJU scores in addition to IB or GCE results.

Otherwise, applicants should submit official scores of any other standardized academic tests for university entrance that they have taken. Note, however, that we do not accept SAT scores. For tests in which it is possible for the candidate to choose examination subjects, subjects relevant to the IUPS (Mathematics, Physics, Chemistry, and Biology) should be included. Examples of specific standardized test scores that may be submitted are in the following table. Note that these are given only as examples.

In cases where the test result is either pass or fail, applicants need to have passed the test. We will accept predicted scores for those who have not graduated yet. Finalized graduation certificates, academic transcripts, and test scores must be submitted as soon as they become available. Applicants may submit their scores or results, or their school may send them directly to the University of Osaka.

#### (4) Please note the following:

- If the documents to be submitted are written in a language other than English, a verified translation into English also needs to be sent. Verification of a translation (consistency between the translations and the originals) may be obtained at an embassy, at the high school of the applicant, or at other organizations.
- For applicants submitting standardized test results that are not automatically delivered to the IUPS by the organization providing the standardized test and that require the applicant's authorization for results to be verified by third parties (such as the IUPS), applicants will be asked at a later time to complete the appropriate authorization document allowing this authorization. The IUPS will reject applications for which the requested authorization will not be provided by the applicant.

#### Application Documents-5

#### Essay 志望理由書

Applicants should submit an essay on the following topic:

#### "Why you wish to study in the International Undergraduate Program in Science".

The essay should be approximately 500-1000 words and written in English. Essays of less than 500 words or handwritten instead of typed may be rejected in the screening.

#### Application Documents-6

#### Application Fee Payment Certificate 検定料収納証明書

Applicants should submit a transaction confirmation or a remittance receipt.

An application fee of 26,800 JPY (Japanese yen) will be required for all applicants applying for admission to the International Undergraduate Program in Science.

The application fee must be paid before submitting the application documents.

#### Application Documents-7

Copy of the Applicant's Passport パスポートのコピー

Applicants should submit a photocopy of the page of (at least one of) their passport(s) showing the photo, name and passport number. Applicants who do not currently have a valid passport should submit a photocopy of another official certificate issued by their country, such as a birth certificate or koseki-shouhon.

#### Application Documents-8

#### Certification of English Language Proficiency 英語能力を証明する書類

Applicants whose native language is English, or who have graduated/are expecting to graduate from a high school in which English is the language of instruction, do not need to submit any English proficiency examination score.

Other applicants need to take one of the English proficiency examinations listed below and send their official score reports, which need to be no more than two years old at the time of submission.

#### (1) TOEFL iBT, TOEFL iBT Home Edition, TOEFL ITP Plus for China

A minimum score of 85 is required. If submitting a TOEFL score, applicants need to send one of the below reports.

- a) Official score report (sent directly from the American Educational Testing Services (ETS) to the University of Osaka)
- b) A copy of the examinee's score record (the document sent to the examinee)

Note: When submitting scores, the points below should be noted:

- \* It may take some time for the official score report to reach the University of Osaka after making a request to the ETS. Applicants should take the exam well ahead of time to ensure that the score reaches our office by the deadline.
- \* The Institution Code of IUPS for TOEFL is **7895**.
- \* Neither 'My Best TM scores nor scores from TOEFL ITP (Institutional Testing Program) are treated as a valid TOEFL score by the IUPS.
- \* For more information, see the Educational Testing Service (ETS) website for an overview of the Test of English as a Foreign Language (TOEFL). https://www.ets.org/

(2) IELTS Academic Module, IELTS Indicator

A minimum score of 6.5 is required. If submitting an IELTS score, applicants need to send one of the following reports.

- a) Test Report Form (sent directly from IELTS to the International College Office, the University of Osaka)
- b) A copy of the examinee's test score report (the document sent to the examinee)

Note: When submitting scores, the following points should be noted:

- \* The General Training module does not qualify for screening.

- \* Mailing address for scores:

- (1) International Baccalaureate with English as an A1 subject at either standard or higher level at grade 4 or above.
- (2) Cambridge C1 Advanced (formerly CAE) or C2 Proficiency (formerly CPE) with a grade of C or better.

# Application Documents-9

Certification of Japanese Language Proficiency 日本語能力を証明する書類 Unless the applicants are native Japanese speakers, they must send one of the documents below.

- (1) A copy of their certificate of Japanese-Language Proficiency Test (JLPT) Level N3 (N2 in case of the Department of Biological Sciences) or higher, which must be no more than two years old at the time of submission.
- (2) A document certifying that the applicant has a Japanese language ability equivalent to or higher than JLPT level N3 (N2 for the Department of Biological Sciences); the document should be prepared by the principal or a Japanese Language teacher of an educational institution.

#### Application Documents-10

#### Other relevant materials

Applicants are welcome to submit additional materials that support their application, such as published articles, certifications of achievement, or participation in internships, summer schools, competitions, etc.

Certifications must be submitted for any achievements mentioned in the essay (see "Application Documents-5"). If certifications of achievements mentioned in the essay are not submitted, the application may be rejected.

# 7. Application Registration and Application Fee Payment 出願登録 及び検定料支払い

#### Preparation

Prepare a computer and a printer connected to the Internet. The Receipt of the Application Fee must be printed out for submission.

#### Application Registration and Application Fee Payment

- i. Applicants should visit the following website for application registration.

- iii. You can proceed to application fee payment by clicking the "Continue to pay" button. If you would like to pay the application fee later, it is possible to pay it by clicking on the URL for application fee payment included in the confirmation email that will be sent to you after completing the application registration. In that case, please make sure to complete the payment by the deadline mentioned in the confirmation email.

Please note that you may not receive the confirmation email if you restrict email reception. If you have restrictions on email reception, please change the email settings so that you receive emails from the sender (@e-apply.jp)\*Furthermore, note that at times the email may end up in the junk-mail folder.

Please note that the application deadline is January 9, 2026, while the payment deadline is January 7, 2026 (all indicated times are Japan time).

Application fees are not refundable except in the following cases.

- a) The applicant did not submit the application documents.
- b) The application documents were not accepted.
- c) The applicant made a duplicate payment by mistake.

Applicants who meet at least one of the above conditions will receive an email containing the instructions to request a refund. The email will be sent to the registered email address. Please follow the instructions and complete the refund request within 7 days.

There are four payment methods that the 'Application Fee Payment System' can accept:

- a) Credit Card
- b) ATM of Post offices or Banks
- c) Internet Banking
- d) Convenience Store
  - a) Credit Card (VISA, Master, JCB, AMERICAN EXPRESS, MUFG, DC, UFJ, or NICOS)

The payment can be completed during the online application.

The card number should be input into the Payment System.

The account holder's name does not need to match the applicant's name.

Please note that payment will be completed at the same time you register your personal information.

b) ATM of Post offices or Banks with Pay-easy option (only available in Japan)

Write down the number displayed after your online application is registered, and pay at any one of the ATMs with Pay-easy option as instructed on the screen.

Banks with Pay-easy option can be checked on the "Selection of Payment Method" page.

c) Internet Banking

After your online application is registered, the page of the site of the bank you chose will open. Make the payment as instructed on the screen

It is required that your bank account is registered for Internet banking.

The payment can be completed online.

d) Convenience Store (only available in Japan)

The fee can be paid at one of the following convenience stores: Seven Eleven, LAWSON, Family Mart, Daily Yamazaki, Yamazaki Daily Store, MINISTOP, or Seicomart

Printing of the Receipt of 'Application Fee Payment'

After the payment is completed, print the documents downloadable on A4 size paper, and send the Receipt of Application Fee Payment with other documents within the application period.

After completing the payment of the application fee, applicants will receive another automated reply e-mail containing a URL for downloading the application form and the mailing address for the application documents.

# 8. Important Notes for Applicants 出願者への注意事項

- (1) If errors are found in the application documents, the application will not be accepted. Moreover, changes to the application documents after submission are not allowed.
- (2) Submitted documents will not be returned.
- (3) Applicants who have provided false information in their application documents will not be allowed to enroll and will be expelled if they have already been accepted.
- (4) All communications from the University, including the screening results, will be sent to the e-mail address provided in the application form. If applicants change their e-mail address, they must inform us of their new address immediately.

# 9. Applicant Selection 選抜方法

Applicants will be selected through the screening of application documents. An in-person or online assessment may also be held. If such an assessment is conducted, successful applicants will be selected based on the results of both the initial screening of the application documents and the in-person or online assessment.

#### In-person or online Assessment

If the University of Osaka considers that an in-person or online assessment is required for an applicant, an assessment will be held for the applicant as follows:

# 10. Announcement of successful applicants 合格発表

Applicants will be informed of the results by email by the end of April 2026.

Successful applicants will also receive an official letter by post in early May 2026.

Successful applicants who have academic qualifications in progress (e.g., IB and A-level) and received a conditional letter of acceptance must submit their examination results as soon as they are available. Failure to meet any of the requirements may affect your admission status.

# 11. The Preliminary and Intensive Japanese Language Education Program 日本語研修・予備教育

(1) Procedure for the enrollment in the Preliminary and Intensive Japanese Language Education Program:

Students will be notified individually of the details of the procedure of enrollment in July 2026.

(2) Enrollment and Tuition fees for the Preliminary and Intensive Japanese Language Education Program

Enrollment fee: 84,600 JPY (as of 2025)

Tuition fees: 173,400 JPY for 6 months (as of 2025)

These fees might be subject to change.

(3) Preliminary and Intensive Japanese Language Education

From October 1, 2026 to March, 2027

The Preliminary and Intensive Japanese Language Education Program will be provided at the Center for Japanese Language and Culture, the University of Osaka to successful applicants who have completed the relevant enrollment procedures. Those who are enrolled in these courses will be registered with the University of Osaka as research students during this time.

# 12.The Undergraduate Education Program 学部教育

- (1) Procedure for the enrollment in the Undergraduate Program in the School of Science: Students will be notified individually of the details of the enrollment procedures in January 2027.
- (2) Enrollment in the Undergraduate School April 2027
- (3) Enrollment and tuition fees for the Undergraduate School

Enrollment fee: 282,000 JPY

Tuition fees: 267,900 JPY per 6 months (535,800 JPY per year)

These fees might be subject to change.

# 13. Handling of Personal Information 個人情報の取り扱い

(1) We will use personal information, such as names and addresses, provided in the application form and submitted documents only for the selection process and for the smooth

implementation of Japanese Language Education at the Center for Japanese Language and Culture of the University of Osaka for applicants who passed the selection process.

(2) We may outsource some of the above-mentioned tasks to a third party. In this instance, we will conclude an agreement with the third party to ensure that it will manage the personal data appropriately.

# 14. Visa/Status of Residence ビザ/在留資格

International students who have decided to study at the University of Osaka must obtain a student visa at a Japanese Embassy or Consulate General of Japan before coming to Japan.

When you apply for a visa, you must submit a Certificate of Eligibility (CoE). The Support Office for International Students and Scholars applies for the CoE to the Immigration Bureau in Japan, and once the certificate is issued, the Support Office will send it to the applicant.

Details will be provided when sending the letter of acceptance.

Please note that if your status of residence is different from "Student", you will not be entitled to any privileges as a foreign student, such as certain scholarship applications.

## 15. Economic Support 経済援助

- (1) There are various scholarships that IUPS students can apply for after enrollment, such as:
  - Scholarships from the School of Science, the University of Osaka
  - Scholarships from local governments or international associations
  - Scholarships from private foundations
- (2) All students of the University of Osaka are eligible to apply for tuition fee exemption. See also the webpage of the University of Osaka.

# 16. Accommodation Support 住居サポート

Students enrolled in this program will be preferentially assigned to an on-campus dormitory for their first year (i.e., six months as a research student and six months as an undergraduate student). Students are responsible for paying their own dormitory fees (20,200 JPY per month as of 2025; subject to change).
