# 1. Program Overview プログラムの概要

The mission of Osaka University is to nurture outstanding individuals who possess a high sense of ethics and wish to become global citizens and leaders in a variety of fields worldwide under the objective of "Live Locally, Grow Globally".

For this reason, the Department of Mathematics, the Department of Physics, and the Department of Chemistry in the School of Science have established the International Undergraduate Program in Science for international students.

Students will be enrolled in the program for 4.5 years in total (half a year as a research student and 4 years as an undergraduate student) culminating in the award of a Bachelor's degree.

This program is overseen by the International College and the School of Science of Osaka University.

The School of Science and the International College welcome:

- Applicants who are curious, have a strong interest in natural science, and are enthusiastic toward broadening their knowledge base.
- Applicants who aim to contribute to the development of science and technology and thus to the whole of society.
- Applicants who have a desire to participate in the creation of new academic disciplines.
- Applicants who wish to develop their ability to describe and present their ideas logically, and improve their communication skills along with their research capabilities in both English and Japanese.
- Applicants who are ethically grounded.

#### The outline of the program is:

- Entrance examinations are conducted in English by each department (or in English and Japanese in the case of the Department of Mathematics).
- For six months prior to regular enrollment, students attend intensive Japanese language education classes and some preliminary science classes at the Center for Japanese Language and Culture (CJLC). During this time, students will be enrolled as research students. The nature of the Japanese language education classes will depend on each student's individual Japanese language ability.
- > Students will then be enrolled as undergraduate students. In the first year, students will take classes mainly in English, and study liberal arts and science major subjects.

- Further advanced Japanese language education will be offered during the first 1.5 years of the undergraduate program.
- Students will focus on specific subjects in the students' respective majors from the second year, and the classes will transition from mainly being taught in English to mainly being taught in Japanese.
- > Students will be assigned to a specific laboratory to conduct research in their final year.

# 2. Duration of the Program プログラム期間

Preliminary and intensive Japanese language education (as a Research Student of the Center for Japanese Language and Culture):

From October 1, 2021 to March 31, 2022 (6 months)

Undergraduate School (as an Undergraduate Student of the School of Science):

From April 1, 2022 to March 31, 2026

#### 3. Student Intake 募集人員

The number of students admitted each year will be small to allow for intensive supervision. Students can be admitted to one of the following three departments:

Department of Mathematics, School of Science

Department of Physics, School of Science

Department of Chemistry, School of Science

# 4. Eligibility for Application 出願資格

In order to apply to this program, applicants must meet certain requirements set by the Japanese Ministry of Education, Culture, Sports, Science and Technology (MEXT). Accordingly, students meeting at least one of the following criteria by September 30, 2021 can apply.

(1) International applicants (students from outside of Japan) who have completed a standard 12-year school education curriculum of a country other than Japan. Included here are applicants who have completed a standard 12-year school education curriculum in a country outside Japan in less than 12 years as a result of being promoted up a grade ahead of their peers.

- (2) International applicants who are at least 18 years of age and who have passed an examination in a country other than Japan which certifies that they have scholastic ability equivalent to a person who has completed a standard 12-year school education curriculum in the said country.
- (3) International applicants who have completed a school curriculum in a country other than Japan that corresponds to that of a senior high school in Japan (including those who have passed an examination which certifies that they have scholastic ability equivalent to a person who has completed such a curriculum), and who have completed pre-university preparatory education required for admission to Japanese universities as designated by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (4) International applicants who have completed a curriculum in a school that is considered to be the equivalent of high school (upper secondary) level and met the requirements stipulated by the Japanese Ministry of Education, Culture, Sports, Science and Technology. The applicants should have completed at least 11 years of education in a country outside Japan at institution(s) that meet standards laid down by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (5) Applicants who have completed a program of study at an educational institution considered within the educational system of a foreign country to be equivalent to the school curriculum corresponding to Japanese senior high school in that country (only if completion of the program is considered comparable to completion of a standard 12-year school curriculum under the country's school education system).
- (6) Applicants who have completed a program of study at an educational institution considered within the educational system of a foreign country to be equivalent to the school curriculum corresponding to Japanese senior high school in that country (even if completion of the program is not considered comparable to completion of a standard 12-year school curriculum under the country's school education system) and who have completed pre-university preparatory education required for admission to Japanese universities as designated by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (7) Applicants who have obtained the International Baccalaureate qualification awarded by the International Baccalaureate Organization in Switzerland.
- (8) Applicants who have obtained the Abitur issued by the Federal Republic of Germany for college entrance.
- (9) Applicants who have obtained the Baccalaureate Diploma issued by the French Republic for college entrance.

- (10) Applicants who have obtained the General Certificate of Advanced Level accredited as a qualification for admission to a university in the United Kingdom of Great Britain and Northern Ireland.
- (11) Applicants who have completed the standard 12-year school curriculum in one of the special schools for foreigners in Japan that are certified by the international evaluating organizations designated by the Ministry of Education, Culture, Sports, Science and Technology (WASC, ACSI, CIS).

#### Notes:

- \* Applicants who have completed their studies at a non-accredited international school in Japan or are unsure whether they are eligible to apply, should contact the office of the International College as early as possible before applying.
- \* Applicants are encouraged to apply only if they plan to pursue their studies continuously and without interruption from enrollment to graduation. In particular, applicants from countries with compulsory-military-service requirements should ensure they do not have to fulfill their military-service requirements while enrolled in the program.
- \* In case applicants do not arrive in Japan by the date designated by the university, their enrollment might be cancelled even if they would be able to start their studies by October 1, 2021.
- \* Even after enrollment, applicants can be expelled for poor attendance or unsatisfactory grades.

# 5. Application Procedure 出願手続

  - After completing the registration, applicants will receive an automated reply e-mail containing a mailing address for the application documents and a URL for downloading the application form.
- (2) Next, applicants should pay the application fee. For more details, please refer to section 7. Application Fee.
- (3) Finally, applicants should post the required application documents to the mailing address that is provided in the automatic reply e-mail after completing the registration. The application documents must be sent by a registered mailing service such as EMS, FedEx, DHL, UPS, etc. We cannot accept responsibility for loss or delay in the delivery of any application materials.

Important notes when preparing the application documents:

- \*Applicants who have not yet graduated from high school at the time of application may submit a certificate of expected graduation and predicted scores for the academic transcript.
- \*If subjects and score details on the academic transcript are written in codes or abbreviations, the appropriate description in English should be attached.
- \*All certificates and other documents need to be certified copies as issued by the school principal or the corresponding highest-level administrator.

#### Application Documents-3

#### Letter(s) of Recommendation 推薦書

Applicants should have at least one letter of recommendation submitted from the principal and/or a senior science teacher of the last secondary school they attended. The letter should include both an evaluation of their personality and academic ability. A science teacher who knows the applicant well is preferable. The letter(s) should be sealed and signed by the principal/teacher (unsealed letters will not be accepted).

# Application Documents-4

#### Results of Standardized Test(s) for University Admission

#### 大学入学共通テストの結果

Applicants should submit official scores of any standardized academic tests for university entrance that they have taken. See (1) to (18) below for information about tests in each country. In cases where the test result is either pass or fail, applicants need to have passed the test. We will accept predicted scores for those who have not graduated yet. Pending graduation certificates, final academic transcripts, and test scores should be submitted as soon as they become available. Applicants may submit their scores or results, or their school may send them directly to Osaka University.

Applicants who are from a country or region without a national standardized test, or who cannot submit their standardized test results during the application period designated by Osaka University, for a reason related to the education system of their country or region, should take (13) or (18), if possible. We recommend applicants take EJU (18) if possible (Chemistry and Physics for Science, Course 2 for Mathematics); otherwise SAT (13.1) (Chemistry, Physics, and Mathematics-2).

#### Please note the following:

If the documents to be submitted are written in a language other than English, a verified translation into English needs also to be sent. Verification of a translation (consistency between the translations and the originals) may be obtained at an embassy, at the high school of the applicant, or at other organizations.

#### (1) Under the International Baccalaureate Educational System

Applicants should submit a copy of their International Baccalaureate Diploma and their IB final examination performance evaluation certificate.

Institution Code of Osaka University's for IB is 036164.

#### (2) Under the German Educational System

Applicants should submit a copy of their Zeugnis der Allgemeinen Hochschulreife and their performance evaluation certificate.

#### (3) Under the French Educational System

Applicants should submit a copy of their Diplome du Baccalauréat de l'Enseignement du Second Degré and their Relevé de Notes.

#### (4) Under the Chinese Educational System

Applicants should submit their results of the National Higher Education Entrance Examination, or their results of a standardized test for university admission administered by the Shanghai Municipal Educational Examination Authority or the Beijing Municipal Educational Examination Authority.

#### (5) Under the Korean Educational System

Applicants should submit their results of the College Scholastic Ability Test.

#### (6) Under the Malaysian Educational System

Applicants should submit their results of STPM (Sijil Tinggi Persekolahan Malaysia). Applicants who wish their results of the U.K. GCE to be considered in the University's screening process, should follow the instructions below described in '(12) Under the U.K. Educational System'.

#### (7) Under the Singaporean Educational System

Applicants should submit their results of the Singapore GCE 'A' Level. Applicants who wish their results of the U.K. GCE to be considered in the University's screening process, should follow the instructions below described in '(12) Under the U.K. Educational System'. Applicants who wish their results of the Malaysian STPM to be considered in the University's screening process, should follow the instructions above described in '(6) Under the Malaysian Educational System'.

#### (8) Under the Thai Educational System

Applicants should submit their results of the National University Joint Entrance Examination.

#### (9) Under the Hong Kong Educational System

Applicants should submit their results of the HKDSE (Hong Kong Diploma of Secondary Education Examination). Applicants who wish their results of the U.K. GCE to be considered in the University's screening process, should follow the instructions below described in '(12) Under the U.K. Educational System'.

#### (10) Under the Taiwanese Educational System

Applicants should submit their results of General Scholastic Ability Test.

#### (11) Under the Egyptian Educational System

Applicants should submit their results of Thanawiya Amma.

#### (12) Under the U.K. Educational System

Applicants should submit one of the following:

- a) Their results of three subjects of the GCE Advanced Level.
- b) Their results of a total of four subjects: two of the GCE Advanced Level and two of the GCE Advanced Subsidiary Level.

#### (13) Under a U.S. Educational System

Applicants should submit their official scores of one of the following:

a) SAT Subject Tests

Recommended SAT Subject Tests are Chemistry, Physics, and Mathematics-Level 2.

Institution Code of IUPS for SAT is **7895**.

b) ACT

Institution Code of IUPS for ACT is **7042**.

c) AP

Recommended <u>AP</u> Subjects are Chemistry, Physics, and Calculus. Institution Code of IUPS for AP is **7895**.

#### (14) Under a Canadian Educational System

Applicants should submit the results of a national standardized test administered by their province as a pre-requisite to study at university.

#### (15)Under an Australian Educational System

Applicants should submit the results of a national standardized test administered by their country or state as a pre-requisite to study at university.

#### (16) Under the New Zealand Educational System

Applicants should submit their record of learning of the NCEA (National Certificate of Educational Achievement) Level 3, or their record of the University Entrance, Bursaries and Scholarships Examination.

# (17)Under the Educational Systems of Other Countries or Regions with National Standardized Tests

Applicants should submit a performance evaluation certificate of a standardized test that they took in compliance with the test regulations.

#### (18) Examination for Japanese University Admission for International Students (EJU)

Applicants should submit their official science and mathematics scores. Applicants should take chemistry and physics for science, and course 2 for mathematics, either in English or Japanese.

#### Application Documents-5

Essays 志望理由書

Applicants should submit 2 essays, on the following topics.

- (1) "Why you wish to study in the International Undergraduate Program in Science".
- (2) "What topic in science has captured your imagination recently, and why".

Approximately 500-1000 words in English for each essay. Essays of less than 500 words or handwritten instead of typed may be rejected in the screening.

# Application Documents-6

Application Fee Payment Certificate 検定料収納証明書

Applicants should submit a transaction confirmation or a remittance receipt.

An application fee of 26,800 JPY (Japanese yen) will be required for all applicants applying for admission to the International Undergraduate Program in Science.

The application fee must be paid before submitting the application documents.

#### Application Documents-7

Copy of the Applicant's Passport パスポートのコピー

Applicants should submit a photocopy of the page of (at least one of) their passport(s) showing the photo, name and passport number. Applicants who do not currently have a valid passport, should submit a photocopy of another official certificate issued by their country, such as a birth certificate or koseki-shouhon.

## Application Documents-8

#### Certification of English Language Proficiency 英語能力を証明する書類

Applicants whose native language is English, or who have graduated/are expecting to graduate from a high school in which English is the language of instruction, do not need to submit any English proficiency examinations score.

Other applicants need to take one of the English proficiency examinations listed below and send their official score reports, which need to be no more than two years old at the time of submission.

#### (1) TOEFL iBT, TOEFL iBT Home Edition, TOEFL ITP Plus for China

A minimum score of 80 is required. If submitting a TOEFL score, applicants need to send one of the below reports.

- a) Official score report (sent directly from the American Educational Testing Services (ETS) to Osaka University)
- b) A copy of the examinee's score record (the document sent to the examinee)

Note: When submitting scores, the points below should be noted:

- \* It usually takes at least one month for the official score report to reach Osaka University after issuing a request to the ETS. Applicants should take the exam well ahead of time to ensure that the score reaches our office by the deadline.
- \* Institution Code of IUPS for TOEFL is **7895**.
- \* Neither 'My Best <sup>TM</sup> scores nor a score from TOEFL ITP (Institutional Testing Program) are treated as a valid TOEFL score by the IUPS.
- \* For more information, the Educational Testing Service (ETS) website for an overview of Test of English as a Foreign Language (TOEFL). https://www.ets.org/

(2) IELTS Academic Module, IELTS Indicator

A minimum score of 6.0 is required. If submitting an IELTS score, applicants need to send one of the below reports.

- b) A copy of the examinee's test score report (the document sent to the examinee)

# 8. Important Notes for Applicants 出願者への注意事項

- (1) If errors are found in the application documents, the application will not be accepted. Moreover, changes to the application documents after submission are not allowed.
- (2) Submitted documents will not be returned.
- (3) Applicants who have provided false information in their application documents will not be allowed to enroll and will be expelled if they have already been accepted.
- (4) All communications from the University, including the screening results, will be sent to the e-mail address provided in the application form. If applicants change their e-mail address, they must inform us of their new address immediately.
- (5) The scores of any applicants who decided not to proceed with their application will be held for two years and then disposed of in line with our program policy for application materials. Scores received after the application period will be disposed of in the same way.

# 9. Applicant Selection 選抜方法

Applicants will be selected through screening of application documents. An in-person assessment may also be held. If such an assessment is conducted, successful applicants will be selected based on the results of both the initial screening of the application documents and the in-person assessment.

From October 1, 2021 to March, 2022

The Preliminary and Intensive Japanese Language Education Program will be provided at the Center for Japanese Language and Culture, Osaka University to successful applicants who have completed the relevant enrollment procedures. Those who are enrolled in these courses will be registered with Osaka University as research students during this time.

# 12. The Undergraduate Education Program 学部教育

(1) Procedure for the enrollment to the Undergraduate Program in the School of Science: January 2022

Students will be notified individually of the details of the enrollment procedures.

(2) Enrollment in the Undergraduate School

April 2022

(3) Enrollment and Tuition fees for the Undergraduate School

Enrollment fee: 282,000 JPY

Tuition fees: 267,900 JPY per 6 months (535,800 JPY per year)

These fees might be subject to change.

# 13. Handling of Personal Information 個人情報の取り扱い

- (1) We will use personal information, such as names and addresses, provided in the application form and submitted documents only for the selection process.
- (2) We may outsource some of the above-mentioned tasks to a third party. In this instance, we will conclude an agreement with the third party to assure that it will manage the personal data appropriately.

### 14. Visa/Status of Residence ビザ/在留資格

International students who have decided to study at Osaka University must obtain a student visa at a Japanese Embassy or Consulate General of Japan before coming to Japan.

When you apply for a visa, you must submit a Certificate of Eligibility for Status of Residence (CESR). The Osaka University Support Office for International Students and Scholars applies for the CESR to the Immigration Bureau in Japan, and once the certificate is issued, the Support Office will send it to the applicant.

Details will be provided at the time of sending the letter of acceptance.

Please note that if your status of residence is other than "Student", you will not be entitled to any privileges as a foreign student, such as certain scholarship applications.

# 15. Economic Support 経済援助

(1) There are various scholarships that IUPS students can apply for after enrollment, such as:

Monbukagakusho Honors Scholarship for Privately-Financed International Students (i.e. JASSO scholarship)

Scholarships from the School of Science, Osaka University

Scholarships from local governments or international associations

Scholarships from private foundations

(2) All Osaka University students are eligible to apply for tuition fee exemption. See also the Osaka University webpage.

# 16. Accommodation Support 住居サポート

Students enrolled in this program will be preferentially assigned to an on-campus dormitory for their first year (i.e. six months as a research student and six months as an undergraduate). Students are responsible for their own dormitory fees (19,000 JPY per month as of 2020; subject to change).
